

HOUSS OF JADE NON-COMPETE AGREEMENT

This Non-Compete Agreement (the "Agreement") is made and entered into on \_\_\_\_\_  
by and between Infinite Milam & Houss of Jade Events, hereinafter referred to as "Houss of

as "Recipient."

WHEREAS, Houss of Jade Events has developed and owns several unique and proprietary  
events, including but **not limited to**:

After-Dark Glow: In the Dark Yoga,  
The MIC Is Hot: Erotic Speak Easy,  
Eat Me: Foodie & Wine'd Down Party,  
Pressed: Dress & Dine Elevated Networking (as the "Events"),  
within 50 miles of Phoenix Proper;

*and*

WHEREAS, Recipient desires to engage in activities that may be competitive with the Events;

*and*

WHEREAS, Houss of Jade is willing to provide Recipient with access to certain confidential  
information regarding the Events, subject to the terms and conditions of this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained  
herein, Houss of Jade and Recipient agree as follows:

1. Recipient agrees not to directly or indirectly engage in any activities or provide services within  
the 50-mile radius of Phoenix Proper that Carry the names or 30% or more of the event context  
for a period of three (3) years following the termination of this Agreement.

To avoid breaching the non-compete agreement. Specific ways not to directly compete  
MAY include:

1. Developing and offering events that are substantially different in nature or theme than the  
Events owned by Houss of Jade. For instance, the recipient may offer events that focus on  
different aspects of wellness, entertainment, or leisure. Avoiding Proprietary Titles of Events.
2. Offering events that take place in a different geographical location than the Events owned by  
Houss of Jade. For instance, the recipient may offer events that take place outside of the  
50-mile radius of Phoenix Proper.

NOTICES OF ACKNOWLEDGEMENT Recipient understands and accepts the following  
statements:

1. Recipient acknowledges that the Events are the proprietary property of Houss of Jade and that Houss of Jade has expended significant resources in developing and marketing the Events.

2. Recipient agrees that during the term of this Agreement and for a period of three (3) years following the termination of this Agreement, Recipient will not, without the prior written consent of Infinite Milam / Houss of Jade, directly or indirectly, solicit, induce or attempt to solicit or induce any of the customers, venues, vendors, employees or independent contractors of Houss of Jade to terminate their relationship with Houss of Jade.

3. Recipient acknowledges that any breach of this Agreement by Recipient may result in irreparable harm to Houss of Jade, and that Houss of Jade shall be entitled to seek injunctive relief to enforce the provisions of this Agreement, in addition to any other remedies that may be available.

4. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

5. This Agreement shall be governed by and construed in accordance with the laws of the State in which this agreement is signed.
